## January Meeting Recap

The University Staff Advisory Council meeting on January 16, 2024 included a lengthy conversation with Jennifer Wilkes, vice president for Human Resources. Members of USAC asked questions about compensation modernization, general salary increases (GSI), and concerns over perceived inconsistent applications of Penn State policies (including remote work opportunities and GSI increases). The meeting occurred prior to the University-wide announcement of a road map to a sustainable business model for Penn State, which includes funding for the implementation of the compensation modernization initiative.

Other highlights from the meeting include updates on an effort to design a sustainable model for USAC to grow into an organization that represents staff across the University to a greater degree than it does today.

## **Committee Updates**

- Awards: The committee is coordinating the USAC Staff Awards. Nominations are now being accepted and are due on March 1. These awards recognize University staff members who go above and beyond their normally assigned job responsibilities, perhaps by resolving a particularly difficult dilemma, being exceptionally creative, or being responsive to the needs of others regardless of status. - **Communications:** The committee helped to announce the 2024 USAC Staff Awards by updating the website, coordinating a <u>press release</u>, and updating the social media channels. The committee also creates this monthly brief and posts relevant information to USAC's <u>Facebook</u>, <u>LinkedIn</u>, and <u>Instagram</u> channels regularly.
- **Membership and Elections:** The committee is working on updates to the USAC application for new staff members to join the Council, among other projects.
- **Diversity, Equity, Inclusion and Belonging:** Members of the DEIB committee are supporting the USAC chair-elect in the planning and implementation of the university-wide listening sessions, which are scheduled for the last week of February. More details, including registration and opportunities to voice concerns, will be forthcoming.
- **Outreach:** The committee is finalizing a Quick Start Guide to share with units across the University that want to start a Staff Advisory Council that engages and advocates for staff in their unit, college, or campus.

## **Additional USAC Updates**

- USAC Travel Engagement Meetings: USAC will visit the Lehigh Valley and Beaver campuses in the coming months, as it continues to engage with staff at every campus. Meeting details and virtual meeting links will be available soon.
  - Eastern Region: Meeting will be held at the Lehigh Valley campus from 10 a.m. 2 p.m. on March 21. Staff from the Abington, Berks, Schuylkill, Wilkes-Barre, Hazleton, Worthington Scranton, Great Valley, and Brandywine campuses are invited to attend.

- Western Region: Meeting will be held at the Beaver campus from 10 a.m. 2 p.m. on June 20. Staff from the New Kensington, Dubois, Altoona, Greater Allegheny, Fayette, Shenango, and Behrend campuses are invited to attend.
- **Collaboration with Faculty Senate:** As Faculty Senate conducts their annual University Park visits to academic colleges and units, USAC representatives have also had the opportunity to attend. The Law School visit was conducted on January 30, the Graduate School visit was on February 2, and the College of Education visit was on February 6. Upcoming visits include the College of Earth & Mineral Sciences on February 20 and the College of Engineering on March 12.
- **USAC Summit:** USAC will host its annual summit on April 18 to bring staff advisory council members from all colleges, campuses, and units across the commonwealth together for a day of learning and networking. The USAC Outreach Committee is in the process of finalizing speakers and programming. More information will be forthcoming.
